**DATA PRIVACY ADVISORY**

Under the Minnesota Government Data Practices Act, you are entitled to know the following about the information, which the City of Coon Rapids collects from you:

1. The following information about individuals who are enrolled in a City of Coon Rapids recreational or social program is classified as private data: name, address, telephone number; other data that identifies the individual; data that describes the individual's health or medical condition, family relationship, or living arrangements and opinions about the individual's emotional makeup or behavior.
2. The information which you provide to the City of Coon Rapids on the roster form is used to process your registration request, to determine City of Coon Rapids staff, facilities and equipment needs, and to assist coaches/managers in notifying participants of scheduling changes.
3. Participation in any recreational program is voluntary, and you are not legally required to provide the information requested on the roster form. However, if you fail to provide the information, you will not be allowed to participate in the program.
4. The information you provide will be made available to City of Coon Rapids staff persons in the Parks Department, program participants, the City of Coon Rapids' insurer and attorney, and to the coach/manager or supervisor, who may be a City of Coon Rapids employee or a volunteer.
